Discussion	Robbie Bennett shared the following updates: - NextSite 360 - Retail Platform used to support Grovetown, Harlem & Evans. Discussion on contract renewal which expires in August 2020 and the possible addition of Martinez as Grovetown may not renew. Next Site provides certain data not available elsewhere.  Robbie discussed Orange 142. Expertise in targeted marketing. Full-service content creation. Expertise in Linked in, SEO - will help stay with and ahead of trends. Kerry shared that the CVB's digital marketing seems to have an uptick in the past year possibly due to the partnership with Orange 142.  DACC processed the \$100,000 grant for the Destination Retail Incentive awarded to Stay, Social Tap & Table.  White Oak Signs are constructed, finishing electrical components.
